The Audrey Wilbur-Ewing Registered Nursing Scholarship

Deadline: March 15th

Selection Process:

- Students are responsible to have the Application forwarded to D. A. Davidson Trust Company Attn: Karen Grove PO Box 2309 Great Falls, MT 59403.
- D. A. Davidson Trust Company will review each application and depending on funds available will determine who will be awarded the scholarship.
- A congratulation letter will be sent to each recipient along with an outline of the requirements that must be met in order to keep the scholarship.

Awarded Recipients:

- A letter will be sent by D. A. Davidson Trust Company to each recipient awarding the scholarship and will outline the requirements set forth below:
 - Must provide letter of acceptance from school of choice
 - Must provide copy of tuition bill indicating that full amount of scholarship is needed for tuition, room and board, and school supplies, excluding personal spending money or sufficient documentation from school
 - o If school of choice's tuition is less than the full scholarship amount awarded, student will only receive amount due by school and no further funds
 - o Payments will be made directly to school
 - If student changes schools mid-year, same criteria applies in addition to the following prior to the second half of scholarship funds being paid:
 - o Providing an **official** transcript showing a 3.2 GPA was maintained
 - o Be a full time student as established by the institution
 - o Continue to show progress towards obtaining a bachelor degree or equivalent degree in the field of professional nursing.
- Awarded recipients qualify for additional scholarship support each following semester for a period of four years by continuing to seek a Bachelor or equivalent degree in the field of nursing and maintain a 3.2 GPA.
 - o Each student will need to submit a letter of request with the name of the school you are attending, current transcript and any other pertinent information by the deadline directly to D. A. Davidson Trust Company Attn: Karen Grove (kgrove@dadco.com) PO Box 2309 Great Falls, MT 59403.
