- THE TEST FOR THE TELL PERMIT (TRAFFIC ED LEARNER'S LICENSE) WILL BE GIVEN ON WEDNESDAY, NOVEMBER 30, 2022 DURING CLASS. I WILL DISTRIBUTE APPLICATIONS FOR A LEARNER'S PERMIT THE FIRST NIGHT OF CLASS. THEY NEED TO BE RETURNED TO ME BEFORE NOVEMBER 30, 2022 WITH A COPY OF THE FOLLOWING INFORMATION:
 - CERTIFIED BIRTH CERTIFICATE <u>OR</u> PASSPORT <u>OR</u> MONTANA I.D. CARD. (IF YOU DO NOT HAVE A CERTIFIED BIRTH CERTIFICATE FOR YOUR CHILD, IT IS HELPFUL TO APPLY FOR A NEW COPY IN ADVANCE ESPECIALLY IF THEY WERE BORN IN ANOTHER STATE.) I DO NOT KEEP THE BIRTH CERTIFICATES, PASSPORT OR MT ID CARD—I SIMPLY NEED TO VERIFY BIRTHDATE AND SPELLING OF NAME ON THE APPLICATION AND WILL PROMPTLY RETURN CERTIFICATE/PASSPORT/MT ID TO THE STUDENT.
 - STARTING SEVERAL YEARS AGO, STUDENTS HAVE TO SHOW A SECOND FORM OF ID. THE
 TYPES OF SECONDARY ID INCLUDE SCHOOL ID <u>OR</u> SOCIAL SECURITY CARD <u>OR</u> FEDERAL
 TRIBAL ID.
 - I AM NOT ALLOWED TO GIVE THE LEARNER'S PERMIT TEST TO STUDENTS WHO DO NOT RETURN PROPER PAPEROWORK. THEY WILL HAVE TO GO TO THE DMV. CURRENTLY THEY ARE BOOKED OUT FOR APPROXIMATELY 2 TO 3 MONTHS.
